

FELONY APPEARANCE SCHEDULE

Attached is the felony appearance schedule for arrest dates, the assigned District Court and date for Felony Appearance Docket. Please note this is for unindicted arrest dates only, except for *capias*. When a defendant is arrested on a *capias*, this schedule should be checked for the next available appearance date so the case can be placed on the Court's docket. Defendants are ordered to appear, without exception, at the times assigned herein unless otherwise ordered by the Court. Defendants in custody shall be transported to Court at a time designated by each Court according to the date of arrest.

THE APPEARANCE DATE AND TIME , WHICH IS ALWAYS 8:30 A.M., MUST BE WRITTEN IN THE PROPER PLACE ON THE BOND IN ORDER TO IDENTIFY THE PROPER COURT.


