**OPEN SESSION:**

1. Receive presentation regarding the I-20 East Texas Corridor Study and discuss as appropriate.
2. Discuss, consider, and take any necessary action to review and/or revise the Smith County No Smoking/No Tobacco Use Policy and the Smith County No Smoking/Tobacco-Free Environment Enforcement Order.
3. Discuss, consider, and take any necessary action to approve a county-wide permit program for charitable organizations soliciting donations in the roadways pursuant to Texas Transportation Code § 552.007.
4. Accept Auditor/Treasurer report for March 2014.
5. Approve and/or ratify payment of accounts, bills, payroll, and transfer of funds, amendments, and health claims.
6. Only if necessary, receive information, discuss, consider, and take any necessary action related to recommendation(s) for all jail projects.
