ORDINANCE NO. 23-0815-05

AN ORDINANCE OF THE CITY COUNCIL FOR THE CITY OF WHITEHOUSE, TEXAS ORDERING A SPECIAL ELECTION TO BE HELD IN SAID CITY ON NOVEMBER 7, 2023 FOR THE PURPOSE OF VOTER CONSIDERATION FOR AN INCREASE OF THE LOCAL SALES AND USE TAX IN THE CITY OF WHITEHOUSE DEDICATED FOR THE BENEFIT OF A SECTION 4B ECONOMIC DEVELOPMENT CORPORATION FROM ONE EIGHTH OF ONE PERCENT (1/4%) TO ONE FOURTH OF ONE PERCENT (1/4%) AND REPEALING THE SALES AND USE TAX DESIGNATED TO REDUCE PROPERTY TAX AND ALLOCATING ONE FOURTH OF ONE PERCENT (1/4%) TO GENERAL REVENUE AND DESIGNATING THE PLACE OF HOLDING SUCH ELECTION; PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Whitehouse is a Home Rule Municipality located in Smith County, created in accordance with statutes of the State of Texas; and

WHEREAS, in accordance with the requirements of Chapter 321 of the Texas Tax Code, the combined rate of all sales and use taxes imposed by the municipality and other political subdivisions of this state having territory in the municipality will not exceed two percent (2%); and

WHEREAS, Section 41.001(a), Election Code, provides that, except as otherwise provided for, each general or special election in this state shall be held on the first Saturday in May or the first Tuesday after the first Monday in November; and

WHEREAS, all constitutional, statutory and legal prerequisites for the passage of this Ordinance have been met, including, but not limited to, the Open Meetings Act; and

WHEREAS, the Council hereby finds and determines that it is in the best interest of the citizens of Whitehouse to hold this election on November 7, 2023.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF WHITEHOUSE, TEXAS, THAT:

SECTION I. INCORPORATION OF PREMISES

The above and foregoing premises are true and correct and are incorporated herein and made a part hereof for all purposes.

SECTION II. ELECTION ORDERED

The City of Whitehouse hereby orders that a Special Election be held on November 7, 2023 for the purposes of increasing the local sales and use tax dedicated for the benefit of a Section 4B Economic Development Corporation from one eighth of one percent (1/8%) to one fourth of one percent (1/4%) and repealing the sales and use tax designated to reduce property tax and allocating one fourth of one percent (1/4%) to General Revenue.

SECTION III. BALLOT LANGUAGE

The ballots for said election shall be prepared in accordance with the applicable provisions of the Texas Election Code so that voters may cast their ballots either "FOR" or "AGAINST" the following proposition which shall appear on the ballot in substantially the following form:

THE INCREASE OF THE LOCAL SALES AND USE TAX IN THE CITY OF WHITEHOUSE DEDICATED FOR THE BENEFIT OF A SECTION 4B ECONOMIC DEVELOPMENT CORPORATION FROM ONE EIGHTH (1/8) OF ONE PERCENT TO ONE FOURTH (1/4) OF ONE PERCENT AND REPEALING THE SALES AND USE TAX DESIGNATED TO REDUCE PROPERTY TAX AND ALLOCATING ONE FOURTH (1/4) OF ONE PERCENT TO GENERAL REVENUE

EL AUMENTO DEL IMPUESTO LOCAL SOBRE LAS VENTAS Y EL USO EN LA CIUDAD DE WHITEHOUSE DEDICADO EN BENEFICIO DE UNA CORPORACIÓN DE DESARROLLO ECONÓMICO DE LA SECCIÓN 4B DE UN OCTAVO (1/8) DEL UNO POR CIENTO A UN CUARTO (1/4) DEL UNO POR CIENTO Y DEROGAR EL IMPUESTO A LAS VENTAS Y EL USO DESIGNADO PARA REDUCIR EL IMPUESTO A LA PROPIEDAD Y ASIGNAR UN CUARTO (1/4) DEL UNO POR CIENTO A LOS INGRESOS GENERALES

SECTION IV. PRECINCTS

The election precinct for said election shall be the regular precinct of Smith County to the extent that they are within the corporate limits of the City of Whitehouse.

SECTION V. ADMINISTRATION OF ELECTION

The Special Election shall be conducted in accordance with the provisions of the Texas Election Code. The City is hereby authorized and directed to execute such election agreement for the election for and on behalf of the City, with all expenses of the joint election borne as outlined in the election agreement. The City of Whitehouse will contract with Smith County for a joint election.

SECTION VI. VOTING SYSTEM

Pursuant to a Joint Election Agreement, Smith County shall be responsible for a voting system that complies with law. Smith County shall be responsible for the preparation of the official ballots for the election, and they shall conform to the requirements of the Code, and in so doing shall permit the voter to vote for three (3) Council Members for two (2) year terms each. No voter shall vote for more than three (3) Council Members for two (2) year terms each.

SECTION VII. EARLY VOTING

(a) In accordance with Sections 31.097 and 271.006 of the Texas Election Code, the following named person is hereby appointed as the Early Voting Clerk for the purposes of conducting said election:

SECTION VIII. NOTICE AND PUBLICATION

That this ordinance, signed by the COUNCIL and attested by the City Secretary, shall constitute the ordinance of the COUNCIL calling, and ordering said election, and that such notice shall be published by the City Secretary in accordance to Texas Election Code and the City of Whitehouse Charter.

SECTION IX. POLLING PLACES

That the POLLING PLACES for this election except insofar as they may be changed by the CITY COUNCIL is attached as Exhibit A.

SECTION X. BALLOTS BY MAIL

Applications for Ballots By Mail (ABBMs) and Federal Post Card Applications (FPCAs) must be received not later than 5:00 p.m. on October 27, 2023. Applications shall be mailed to:
