

CLASS "A" & "B" MISDEMEANOR 2024 – 2025 ARRAIGNMENT SCHEDULE

The attached schedule is based on arrest dates only, except for arrests on capiases. When a Defendant is arrested on a capias/alias capias, the schedule should be checked for the next closest arraignment in order for the case to be placed back on the appropriate court's docket. Oftentimes a Defendant is arrested on a bond forfeiture, surety to surrender principal (SOB) or an insufficient bond warrant, in which case the court should be contacted to determine whether a new arraignment date is necessary.

The APPEARANCE DATE AND TIME OF 8:00 A.M. (no exceptions) must be written in the proper place on the bond in order to identify the appropriate court. Further, all Defendants are hereby ORDERED, to appear without exception.



Usually all case numbers beginning with "002" are assigned to the **County Court at Law #2, Judge Sara Maynard, Presiding**, unless it was ordered transferred to a different court.


Usually all case numbers beginning with "003" are assigned to the **County Court at Law #3, Judge Clay White, Presiding**, unless it was ordered transferred to a different court.

NOTICE: Please note that there are a few "Thursday" Arraignment dates.


