At a special meeting of the Commissioners Court of Smith County, Texas, with County Judge Larry Craig presiding and Commissioners B.J. Payne, Jerry Shamburger, Gene Chandler, and Andrew R. Melontree being present, the following business was transacted, pursuant to the notice being duly posted, to-wit:

The invocation was given by County Engineer, Kenneth Cline.

The pledge was led by Commissioner Jerry Shamburger.

Motion was made by Commissioner Gene Chandler, seconded by Commissioner Andrew R. Melontree, which motion carried unanimously that the Commissioners Court approve a request from the County Engineer for the following utility adjustments:

Southern Utilities Company to place a 3/4" fresh water service line within the right-of-way of County Road No. 2138.

The lines will be constructed and maintained within the County right-of-way as directed by the County Engineer in accordance with current Smith County specifications.

Motion was made by Commissioner Gene Chandler, seconded by Commissioner Andrew R. Melontree, which motion carried unanimously that the Commissioners Court approve a request from the County Engineer for a speed limit sign of 35 mph to be located on County Road No. 213 from County Road No. 214 North to Lakeshore Drive.

Motion was made by Commissioner Jerry Shamburger, seconded by Commissioner B.J. Payne, which motion carried unanimously that the Commissioners Court postpone agenda item number eight (8) regarding the cancellation of the contract with Data Pro, Inc. for further study and consideration.

Motion was made by Commissioner Jerry Shamburger, seconded by Commissioner B.J. Payne, which motion carried unanimously that the Commissioners Court designate the area for foreclosure sales as 25 feet at or near and including the outside steps and the main hall of the West entrance of the Smith County Courthouse.

Commissioners then went to item number one (1) on the agenda regarding discussion items only. Chris Bull and Debbie Lauman were present and brought along a member of the 4-H group to present the Commissioners Court with "Youth Statistics."
